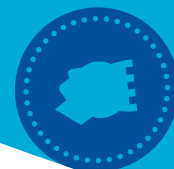


A guide for employees

What is payroll giving?

Payroll giving (sometimes known as Give as You Earn) is a tax efficient scheme that allows you to make a regular donation to The Christie charity directly from your salary. The donation comes out of your pay before you are taxed, so effectively your donation costs you less!

Donation amount	Cost to standard rate taxpayer	Cost to higher rate taxpayer
£5	£4	£3
£10	£8	£6
£15	£12	£9
