

Design of car parks to be soft in the landscape	Desire to stay within Strategic Planning Framework parameters	
Use of timber/green walls as a material where appropriate	Respect former building line on Golden Lion site	
Surface treatment to soften impact	Need to fully consider access/egress + bottlenecks/mitigation	
Golden Lion: Brick over tier, with lighter facades on upper levels	Functioning of road system – Cotton Lane Jct. not working, exacerbated by Blue Badge Parking	
Green neighbourhood = natural materials	Concern over light intrusion	
Impact on Maggie's Centre – Amenity, Views, Proximity	Need to retain Withington Green	
Provide key worker accommodation/ Garden Space to front/top of car parks	Need to offset carbon emissions. Concern over air quality	
Preference for basement car parking to reduce massing	Golden Lion Site and access holding back

- Joint working arrangement agreed








